South Carolina Residency Regulations (Section 62.606.B.)

Active duty members of the United States Armed Forces and their dependents are eligible to pay in-state tuition and fees as long as they continuously claim South Carolina as their State of Legal Residence during their military service. Additionally, certain members of the armed services and their dependent relatives may be eligible to be charged a tuition rate less than the out-of-state rate while stationed at a military facility in South Carolina whether or not they qualify as residents for tuition purposes under Statutory Authority: 1976 Code Sections 59- 112-10 to 59-112-100.

Documentation is required for service members who are stationed in South Carolina or for whom South Carolina is the State of Legal Residence.
