Report from CAS Committees..... Jo Koster

The following course changes and modifications were unanimously approved.

a. Department of Biology

- i. Add course: BIOL 213, Anatomy/Physiology I.
- ii. Add course: BIOL 214, Anatomy/Physiology II.

The BIO 213 course was approved with the following revisions:

- Change the prerequisites to “HMXP 102, Gen Ed Math, and one of the following: BIO 150/151, BIO 203/204, NUTR 221, or another equivalent course.”
- Add Assessment Support Details to indicate why this change in curriculum is being made.

The BIO 214 course was approved with the revision to add Assessment Support Details indicating why this change in curriculum is being made. After discussion, no change was made to the prerequisites.

b. Department of English

g. Department of Sociology & Anthropology

This item was approved without dissent.

2. Program change proposals

a. Department of Interdisciplinary Studies

- i. Modify program: BA-SCST-CSST.

This item was approved upon the following revisions:

- Change the total number of credit hours to 120-123
- Add Assessment Support Details indicating why the change in curriculum is being made.

3. Blanket Petitions

a. Department of History

- i. For the MA in History (the “with thesis” option), in the 2016-17 catalog, require that all students complete at least 30 hours of approved graduate-level courses including HIST 695 and HIST 696.

This item was approved without dissent.

b. Department of World Languages & Cultures

- i. For the BA in Spanish, in all previous catalogs, allow SPAN 360-001 (offered Fall 2016 as *History of Latin American Music*) to satisfy the major requirement normally satisfied by SPAN 421 or SPAN 422.

This item was approved without dissent; however, there is no BA in Spanish so this approval is for the BA in Modern Languages with Concentration in Spanish.

4. Student Petitions: There were no student petitions

Dr. Koster reminded the faculty that there are two different boxes on the curriculum application form. The top box says, “course justification for course action.” In this box explain why you are doing the action and include the date of the department meeting when you voted. “Assessment Support Details” is past assessment that lead to this change. These two boxes help us demonstrate to SAKS that we use assessment to update curriculum.

Update on the BPS and PLA Committees.....M. Gregory Oakes

Bachelor of Professional Studies and Prior Learning Assessment committees are designed to help students already working in their prospective fields. These committees proposed the following;

- a. Creation of a PLA office with a director
- b. Development of a course in which students create a PLA portfolio. Faculty reviewing portfolios would be compensated for their work.
- c. The BPS committee is considering adding concentrations like healthcare and criminal justice for those that are already working in the field.

Dean’s Remarks Karen M. Kedrowski

The dean announced good news:

- a. Dr. Amanda Hiner, the CRTW coordinator from the English Department, was invited to speak at Texas Wesleyan University on integrating critical thinking into the curriculum.
- b. Dr. Janice Chism was featured on the Academic Minute for her research on monkeys.
- c. Two administration support staff members have been named staff employee of the month.
- d. The Winthrop Social Work Department was ranked 23rd in the nation by Graduate programs.com for its MSW program.
- e. The department of Social Work has a research partnership with the Catawba Nation to focus on the needs of the elderly. Dr. Deana Morrow was named accreditation reviewer for the Council of Social Work Education.
- f. The Mass Communication Department hosted Mass Communication Week, which featured alumni and industry professionals.
- g. Several Arts and Sciences programs have recently been highlighted by the American Association of State Colleges and University including various general election activities and the Boy Scout program that lead to the rain gardens.
- h. Dr. Jennifer Disney received the alumni professional achievement award from McDaniel College

The University is revising its faculty search processes.

- a. The committee is trying to make sure documents and processes on the website reflect that CAS now has a committee on personnel action.
- b. The committee is trying to go paperless.
- c. The Dean is working with the chairs on the Dean’s Council to create a document with ‘best practices’ to ensure a diverse pool of applicants and define how the diversity committee will ensure this diverse pool.
- d. There are five approved faculty searches and one administrative search.

The Dean thanked the departments and programs that held events related to the election: Interdisciplinary Studies, History, Mass Communication, Political Science, Philosophy and Religious Studies, and the West Forum. Student organizations also participated in election events including the College Democrats, College Republicans, Political Umbrella Group, NAACP, and Council of Student Leaders among others. Individual faculty members in CRTW and ACAD allowed voting ambassadors to come to class. The College held 35 election related events.

The Dean reminded faculty that the registration deadline for the state of South Carolina has passed and students will not be eligible to vote in the election if they have not already registered. If students wish to cast an early vote they will need an absentee ballot. If they are registered in York County students can go to City Hall or the Election Commission building in York to cast their votes.

There are three film festivals sponsored by various entities in the College of Arts and Sciences:

- a. Spanish film festival
- b. French film festival
- c. Native American film festival

The campus wide Qualtrics license has been renewed and enhanced to allow users to attach documents. Department chairs are now using Qualtrics to secure override requests. The College of Arts and Science scholarships will be done electronically in the spring. For more information contact Christina Stiles.

The Office of Accessibility will be reviewing the absence policy for students with disabilities or medical conditions.

The Provost Office has put together a guide to match students with student resources to be used during advising or if students are feeling distressed.

3. Blanket Petitions

i. *For the BS in Biology* (all concentrations), in the current catalog and all previous catalogs, allow BIOL 540 *Human Ecology* to count toward the major requirements – either to satisfy Area A of the biology curriculum, or to count as a biology elective in Area C.
ii. *For the BS in Biology* (all concentrations), in the current catalog and all previous catalogs, allow BIOL 316X and BIOL 316 to count toward the major requirements – either to satisfy Area B of the biology curriculum, or to count as a biology elective in Area C.

These items were approved without dissent.

- b. Department of Human Nutrition
 - i. For the BS in Human Nutrition, in the current catalog and all previous catalogs, add ACCT 280 and HLTH 300 to the list of DPD elective courses.
This item was approved without dissent.
- c. Department of Interdisciplinary Studies
 - i. For the BS in ENSC, the BA in ENST, and the minor in SUST, in all catalogs, allow SOCL 350 *Animals & Society* to count as an elective toward the major/minor requirements.
This item was approved without dissent.
- d. Department of Mass Communication
 - i. For the BA in MCOM and the BS in IMC, in all catalogs, waive the requirement that students take 72 hours in liberal arts & sciences. This requirement is not part of the actual catalog, but is currently showing up in DegreeWorks.
This item was approved without dissent.
- e. Department of English
 - i. For the BA in ENGL, in the current catalog and all previous catalogs, allow students to count ENGL 308 up to three times for credit toward graduation in the major.
This item was approved on 12/21 after the regular committee meeting.
