- Introduction from Jo Koster
 - o Congratulations for being 7 weeks into the semester!
 - o Thank you for all of your hard work
- Vote to approve minutes from September 4, 2020 Jo Koster

- Curriculum Committee Dave Pretty
 - Course changes: Political Science
 - PLSC 200 intro to political science
 - PLSC 311 improvement on constitutional law series (this course and below)
 - PLSC 311H
 - PLSC 312
 - PLSC 318
 - PLSC 318H
 - Majority vote yes, courses pass
 - Program changes and petitions
 - BA-MCOM modification to add specific technology requirement (1/2 credit)

- Old Business
 - Update of the College Policy on Handheld Technology Greg Oakes
 - Changing from "handheld" to digital
 - Updated to include all types of digital tools, not just handheld phones
 - Added policy on prohibition of publication of course recording without instructor consent
 - Added policy on prohibition of publication of course proceedings that denigrates or decontextualizes instructor or student
 - Motion and second
 - Question: The folks in the Accessibility Office made it clear that SC law allows students to record any class. Does the policy reflect that?
 - Answer: yes, it does
 - Vote: majority yes, motion passes
 - o Updated on FCUP discussions based on college input Ginger Williams

- Furloughs
 - Questions brought: why didn't we choose a model that was more progressive (e.g. exemption those who make poverty wage)? Why didn't those making over \$100,000 furloughed proportionately more? Why weren't there more tiers?
 - Many pointed out that faculty simply cannot take off 15 days during our nine-month contract
 - Inadequate information concerning whether to take a lump sum or not given the amount of time that was given to make a decision
 - All these concerns have been sent to the president and will be following up
- COVID-19 Pandemic
 - Clearly written guidelines with regards to tenure/promotion
- Influence of politics and politicians on the University
 - Concern over the amount of time given to address the board, disproportionate hiring of administration compared to faculty/staff
- Ginger Williams will take these issues to the president at their next meeting and will report back in January about how the president responds to the issues
- Takita offers update on a few of these issues
 - Changes with annual reporting that work is taking place at the college level & it will be further abbreviated
 - Changes with tenure/promotion college has been having conversations about how we will move forward specifically with tenure/promotion
- Jeannie Haubert comment on influence of politics & politicians on the University reference to article in Chronicle of Higher Education that spoke to similar problem at University of South Carolina and shared this article as well: chronicle.com/article/the-new-order; wants to state that the article is scrutinizing the underpinnings of the system & setting policies about free speech; encourages faculty to be more involved and pay attention to what is happening at board meetings; how is what is happening at Winthrop fitting in with larger nationwide trends

New Business

- Updates to advising and retention processes Dr. Jamie Cooper, Dean, University College
 - Introduced by Jo Koster (English)
 - Student Success and Retention Workgroup
 - Evaluation of institutional policies and procedures to identify barriers to student registration
 - Opportunities for enhanced alignment of retention activities across all academic student support units
 - Create operational plans and submit recommendations to leadership and shared-governance bodies as necessary to modify university policies and procedures
 - Enact change!
 - Want to have some movement on retention as retention has been a focus for many years

- Deliverables for this year:
 - Create integrated workflow to support enrollment and retention
 - Standardize data workflows to units to inform student outreach
 - Review use of advising flag
 - Explore pre-registration of new students prior to orientation
 - Review transfer policies and processes
 - Review university-wide advising models and practices (including how to most effectively utilize student services, faculty expertise, helping navigate gen ed/program requirements)
- The weeks ahead advising & interim grade reports
 - Special grading for fall 2020
 - Extended S/U & withdrawal deadlines
 - Early registration starts Nov 10 (9th for special populations)
 - Thanksgiving break starts 11/24 & the last day of in-person instruction is 11/23 with Nov 21 being a remote learning day. Classes resume 11/30; last day of classes is 12/3
- Resources have been created for students and faculty on S/U, GPA calculator, LIFE GPA calculator, DegreeWorks & DegreeWorks resource page

• Questions:

- unanswered question: Siobhan Brownson What grading system is being used for students who took a grade of Incomplete in Fall 2019 and whose final grade will be due soon? Answer found after meeting per Tim Drueke: I would think they should be graded based on the grading scale in place for the semester in question. So a Fall 19 incomplete would be graded using the regular grading options. The CR/UN for Spring 20 incompletes probably would be appropriate, even if the other students in the class are on regular grading. (I am thinking regular grading will likely be in effect for Spring 21).
- Matt Hayes shouldn't positions to help at-risk students be exempt from the hiring freeze? isn't that a WIG-related issue?
 - o Have considered this, working as best they can
- Note from Brandon Ranallo-Benavidez: Also, when talking with students and/or advisees, if they cannot get internet at home for the end of the semester, they can work with housing to stay on campus until the end of finals.
- Using the AIM Testing Portal Karen Medlin, Test Center Operations Manager
 - It's a comprehensive accommodation, appointment, and case management software. AIM allows students to electronically request their accommodation letters and forward them to you (via email) in classes where they decide they need their approved accommodations. It also allows them to schedule their OA Test Center appointments all in the same place.
 - Allows faculty to see all the students in your class who have requested their Letter of Accommodation (LOA). You will now submit just one Alternative Testing Agreement for your course, as opposed to completing a form for every test. As long as the parameters are the same, you can copy it to another section.

This is where you will also upload any exam materials and download completed exams.

- Updated website still under health and counseling but links have changed as slowing moving out from under health and counseling
- Students now have to give 5 business days' notice to testing center for accommodations – encourage students to get these in on time
