### **CAS Curriculum Committee Report**

August 25, 2020

## 1. The following graduate course actions were approved

i. Modify course: BIOL 542, Global Change Biology

In the section on additional work for graduate students, replace the existing text with: Graduate students will write paper that reviews the primary literature on a specific topic related to global change and includes a small meta-analysis assessing the effect of a component of global change on a specific response variable. In addition to primary and secondary sources used to summarize the significance of the topic, graduate students will be required to find primary literature articles with data related to a specific response variable. Rather than just describing the results of studies, graduate students will make tables and/or graphs that summarize patterns across studies. Depending on the specific topic and the data available, analyses could focus on effect sizes or general patterns. Synthesis of published data to detect general patterns is a foundational skill that a graduate student should possess.

### ii. Modify program: MS-NUTR

The graduate advisor decides among options (thesis, nonthesis, DI with thesis and DI with nonthesis) if students should do a thesis or not to avoid students' confusion. The thesis will be used as graduate electives.

iii. Modify course: NUTR 600, Seminar in Food and Nutrition

Adding the course name where they have been left out to be more consistent.

iv. Modify course: NUTR 607, Research Methods

Adding the course name where they have been left out to be more consistent.
