I. Welcome – Karen Oremus, Interim Dean

The Interim Dean welcomed everyone and began the meeting at 2:06 PM. She introduced Amanda Foshag, the new Administrative Assistant for the Department of Fine Arts and the Department of Design.

II. Approval of the Minutes from the 08.16.22 Assembly – Karen Oremus

Alice Burmeister made a motion to approve the minutes, Jason Tselentis seconded, and the minutes were proved by all.

III. Curriculum Review + Vote – Lorrie Crochet, Associate Dean

Lorrie Crochet began the review of proposed curriculum changes. She went through the list and invited each Department's representative to summarize the proposals one at a time.

- a. Ron Parks for the Department of Music CVPA voted and approved the changes as submitted.
- b. Daniel Gordon presented for the dance program in the Department of Theatre and Dance CVPA voted and approved the changes as submitted.
- c. Kyle Sweeney represented the Department of Fine Arts CVPA voted and approved all changes as submitted.

IV. Department + Unit Reports Max 2 minutes each

- <u>Department of Design Jason Tselentis, Chair</u>
 Chair Tselentis noted redecorating, changing, and moving things around to be ready for the Open House. He invited everyone to visit Tamara LaValla's exhibition if they have not seen it.
- b. <u>Department of Fine Arts Mark Hamilton, Interim Chair</u>

Interim Chair Hamilton reported that the Fine Arts workshops have been moved to November 5th and 70 students have already signed up. He noted that this is an important tool for recruitment, NASAD visit prep is underway; Kyle Sweeney is leading the efforts and Fine Arts has met with Design and the Dean regarding accreditation.

c. Department of Music – Elisa Koehler, Chair

Chair Koehler reported that the concert series has begun and visiting artist events are coming up. For accreditation, Justin Isenhouer has been selected to lead the self-study. The Chair said she was able to do a walk-through of Byrnes Auditorium and noted that was the first time she has been inside since she's been working at Winthrop. RFPs have begun. Estimated date of reopening is August 2024.

- <u>Department of Theatre + Dance Daniel Gordon, Chair</u>
 Chair Gordon reported noting that the production series is moving forward successfully. He recaptured the line-up.
- MAAA Program Robert Wildman Robert Wildman reported for arts administration stating that they are graduating 5 students in December 2022. The program is experiencing some hindrances regarding hiring out of state professors; thus he is hiring some new adjuncts and gaining recommendations.
- f. <u>ST-ARTS + Arts Bridge Program Jeff McEvoy</u> Jeff McEvoy indicated that screenings and recruitments will begin in November.
- g. Arts in Basic Curriculum Institute Kim Wilson



ABC institute reported that conference season has begun and will be heavy into November. Kim Wilson shared a take away flyer and gave kudos regarding the Arts Bridge program ("it is doing great!"). It provides learning patterns and offers information on areas of improvements for helping arts integration. She thanked the faculty who are teaching in this program.

V. Dean's Office Updates + College Business

- a. Director of CVPA Communications Lauren Taylor Grad
 - Saturday, October 8, Fall Open House Lauren Taylor Grad reviewed the lineup of the Open House and mentioned that they are working to increase excitement.
 - She shared that Arts Winthrop T-shirts will be arriving in the next few weeks. These are for full time faculty and volunteers. They will be sold for revenue.
 - The micro website is down. CVPA Winthrop Web page will be updated to show a slideshow of events and announcements in the interim.

- b. Student Services Director Anna Fredericks (Karen Oremus reported)

- c. Associate Dean Lorrie Crochet
 - Monday, October 17, 8:30-3:30 Olde English Consortium Professional Development Conference for Arts Teachers in SC. Associate Dean Crochet reviewed the Old English Consortium details noting 365 arts teachers will be in the arts buildings on campus and in DiGs conducting sessions (16 sessions per the 4 blocks). "We are excited to have them here as well as them to be here we hear as this is important for recruitment."
- d. Interim Dean Karen Oremus
 - Update on Faculty and Staff Vacancies: Interim Dean Oremus reviewed the faculty and staff vacancies and shared that in Academic Leadership Council, she requested to have permission to hire as soon as possible.

Interim Dean Oremus and Associate Dean Crochet left the meeting.

Ι. **CVPA Town Hall** (Guests)

> Provost Peter Judge welcomed everyone to the Town Hall. He began by introducing himself, his new role, and the staff of the Office of the Provost and Academic Affairs.

- Π. **CVPA Town Hall** (Questions)
 - 1. "Why does Winthrop not employ external reviewers for tenure and promotion cases? Is it possible to start implementing that process? Other institutions do this."



Response: Provost noted that this has not been done at Winthrop before. <u>Disadvantages</u> to this process regard the limited amount of time required to accomplish these tasks. It also may be cost prohibited. <u>Advantages</u> to this would be that this is a good housekeeping standard, if implemented. One faculty member noted that he was invited to do this for another institution and had to decline because of the short time frame required.

It was asked how this would benefit junior faculty? If done, peer institution pairings would be the most effective approach perhaps. One faculty member noted that he would not want an outsider reviewing his application in this way. Meg Webber stated that "we will look at possibly changing this."

2. "Is it possible to create a process by which departments could make requests for budget needs; making cuts without addressing needs creates unintended hardships?"

Response: Provost "We do this."

3. "In today's world, a great web presence is more crucial than ever before. Winthrop's official website is below average in many regards. Beyond its dated appearance, it is often difficult to use. For CVPA, especially, the constraints placed on our web presence are stifling and highly detrimental. 10 years ago, a NASAD consultant observed: "The University web presence for Winthrop is a bit difficult to navigate and is very 'vanilla'." On the University mandate that everyone use the same webpage template, the consultant remarked: "That will definitely hamper recruiting for the art/design areas where visual innovation is the rule, rather than the exception."

Evidence of this is bearing out. If we don't look compelling online and showcase our programs effectively, few prospective students are going to be excited about applying and visiting in person. Our competitors, such as Anderson University's School of the Arts, have stunning contemporary websites that highlight their programs in an appealing and exciting way that privileges the visual and creative aspects of their departments.

What can Senior Leadership do to transform CVPA's digital presence so that we are attractive to prospective students and competitive with our peers' marketing and visual identity strategies? We call ourselves the "leading College for the arts in the Carolinas" but we definitely don't look like it online. Indeed, our current website template was not built for high-impact multimedia content, much to the detriment of the visual and performing arts at Winthrop. We need significant updates because our competitors are doing it much better than we are."

Response: Dr. Judge agreed that the website does need updating. He followed-up with the following remarks: "Gray Associates may address this in their review. Whereas continuity for a website is effective, the current version does seem very yesterday."

A faculty member asked if it would be possible for CVPA to create the site ourselves.

Response: The Provost said "yes, we can consider that as an option." It was asked "how the faculty would or staff would the faculty or staff get reimbursed for that?" Dr. Judge said a



service trade could be implemented, for example, not all faculty need are advisers. He stated "we can consider our options."

A faculty member referred Social Design House as an option to hire, noting this is a project that they could take on. They are alumni of Winthrop and they understand the University's brand. A committee could be created possibly to help shape the site's design and content needs.

A sense of urgency was stressed by several faculty members, following a comment Dr. Judge made about the consultant firm Gray looking at the big picture of Winthrop's website. Another faculty mentioned that there is a template already in place and that it just needs activating.

Response: Meg suggested to let CVPA be the first college to do their own web design, as a beta test; making it a sample to make a case for other colleges who may want to do their own.

- 4. A faculty member expressed concern regarding the lengthy admissions process for incoming students. This became evident to him when his wife, a current student, recently went through the process. He also suggested that Winthrop consider implementing a nursing program; stating that York Tech has one. It is extremely popular with a six year waiting list.
- 5. A faculty member expressed support of the Interim Dean for advocating vacant faculty line support; noting that we are behind the curve for getting quality candidates at this time of the year so we need to take action.

Response: The Provost shared that he talked with the President yesterday (October 6) and "we are ready to move forward with some of these position lines." He also noted that they will be working with the consultant Gray on program economics to get Winthrop in shape to make the best use of its resources.

6. A faculty asked all Academic Affairs staff to please come and visit CVPA - to see and experience what the departments do differently. He also said that often "the arts are square trying to fit into a round hole. But that a sense of encouragement has been generated by this discussion."

Response: Dr. Judge made an analogy, referencing a quote from a recent meeting: "to get out from behind the fence." He stated that he needs to do just that: to get out of the office and visit classes where he can learn more by observation and engaging with the faculty and students.

7. A faculty member stated that the facilities in McLaurin are deplorable and asked what could be done. She shared "we really need OSHA to come in and inspect; however, we are not going to call them in because where will we go if they put us out of these buildings?" How can we sell Winthrop to strangers when our facilities are in the state that they are in?"

Response: The Provost noted that 10 million or so has been appropriated recently and that James Grigg has plans - improvements are on thee to-do list. A request can be made of



Faculty and Administration to obtain an update on needs. Facilities have been neglected for a long time and the President knows this.

8. A faculty shared the following by email prior to the meeting, "Winthrop is in financial trouble," a student recently told me. I read on a social media app how Winthrop used to get something like 40% of its funding from the state but now its maybe 7%. How do Winthrop's leaders respond to those rumors and students' fears? What university fundraising steps are being taken to help with this?"

Response: Dr. Judge shared that Winthrop is a public institution and the state support is more like 13%. He noted that Advancement is doing things such as reaching out to the community and local businesses asking for support. But, that he will bring this up to Senior Leadership. Dr. Judge expressed that the President is encouraged with the community building process that has been taking place. Gary Simrill, the new hire in the Office of the President, has been able to make some difference due to the influence of his network.

Regarding student fears, rumors, the Provost said "it is vital that we to put out a message that is positive. He stated that the President and Justin Oates had recently been in Columbia speaking to the government about making a case for more support for Winthrop.

Dr. Judge noted that Joseph Miller is bringing in a new approach to enrollment and retention, which is encouraging. Dr. Judge then encouraged everyone to vote and to tell our story as best as we can.

9. A faculty member asked "but when students see that courses are being canceled due to low enrollment, how do we change the messaging the messaging to be positive when the data doesn't speak it?"

Response: Dr. Judge said that Course Dog will help the University predict needs for courses. Tim Drueke noted that Course Dog is still in the "designing stage" to help with this and it will help navigate through the organization of needs regarding majors; the appropriate number of faculty to cover the courses so that the students make out what they need.

10. A faculty noted that pronouncements of the University this summer impacted his program in CVPA affecting the faculty, the students, and the courses of this online program. A request was made for programs affected by such pronouncements, to get notice before they are made to help rectify situations that may occur after the changes are implemented.

Response: The Provost said that he will work on better ways of communicating such actions. Yet, he acknowledged that budget is always a challenge as are state laws.

11. A faculty member thanked the Academic Affairs staff for being present and said that the answers give us hope and the website is a great way to start to share the positive things that CVPA does. "That is the great opportunity."

Response: Dr. Judge stated "it's about the people and not the numbers."



12. A faculty member **encouraged the Provost to keep thinking of the faculty and ways to boost morale by supporting faculty and staff.**

Another faculty member expressed appreciation for the Academic Affairs' visit; recapping that what is being said is that: "we need to be the best we can be regarding viability, visibility, and value. Noting that it is vital to continue to address how the values are being allocated; how can we turn my colleagues' courage and poignant thoughts into a product we can value?"

Response: The Provost shared that this is a primary goal.

Program Description

• Through a focused investigation of the visual traditions of civilizations that are often marginalized in mainstream art historical narratives, students will examine the values, attitudes, and beliefs of peoples from across the globe, as well as consider how their own modern values, attitudes, and beliefs may or may not be reflected in or influenced by these diverse visual cultures. Moreover, this minor by its very nature examines art and visual culture from multiple perspectives and requires students to make connections across different fields of study and to understand the linkages between them. Justification for Program Change:

• The Department of Fine Arts currently offers a variety of global/world art and visual culture courses each semester. The new minor draws on these specific courses to provide students an opportunity to expand their breadth of knowledge of art and visual culture beyond the traditional Eurocentric "canon," develop intercultural competencies, and consider how art was rarely the product of a single culture working in isolation.

Justification for Program Change:

- The Minor in Global Arts and Visual Culture is distinct from the existing Minor in Art History in that it requires fewer foundational courses and places a much stronger emphasis on a tailored set of elective courses developed and taught from a global perspective.
- Indeed, the minor offers a "pre-built" selection of globally focused courses with an emphasis on breadth. This structure ensures students who complete the minor are exposed to the broadest possible variety of visual cultures from across the globe and highlights the visual traditions of non-western civilizations that are often marginalized in mainstream art historical narratives.

"In today's world, a great web presence is more crucial than ever 1. before. Winthrop's official website is below average in many regards. Beyond its dated appearance, it is often difficult to use. For CVPA, especially, the constraints placed on our web presence are stifling and highly detrimental. 10 years ago, a NASAD consultant observed: "The University web presence for Winthrop is a bit difficult to navigate and is **very 'vanilla'**." On the University mandate that everyone use the same webpage template, the consultant remarked: "That will definitely hamper recruiting for the art/design areas where visual innovation is the rule, rather than the exception." • Evidence of this is bearing out. If we don't look compelling online and showcase our programs effectively, few prospective students are going to be excited about applying and visiting in person. Our competitors, such as Anderson University's School of the Arts, have stunning contemporary websites that highlight their programs in an appealing and exciting way that privileges the visual and creative aspects of their departments.

VI. CVPA Town Hall (Questions)

• What can Senior Leadership do to transform CVPA's digital presence so that we are attractive to prospective students and competitive with our peers' marketing and visual identity strategies? We call ourselves the "leading College for the arts in the Carolinas" but we definitely don't look like it online. Indeed, our current website template was not built for high-impact multimedia content, much to the detriment of the visual and performing arts at Winthrop. We need significant updates because our competitors are doing it much better than we are."
