Faculty Conference Minutes February 24, 2017

- I. Motion to Conduct Business without a Quorum.
 - a. A motion was approved to conduct business in the absence of a quorum.
- II. Approval of Minutes for December 2, 2016 Faculty Conference
 - a. After accepting some minor changes to the minutes, the minutes were approved.
- III. Report from the Chair, Dr. John Bird
 - a. Dr. Bird thanked everyone for being present at Faculty Conference.
 - b. Dr. Bird gave a brief report concerning the February 3-4 Board of Trustees Retreat.
- IV. Report from the President, Dr. Dan Mahony
 - a. President Mahony gave a budget overview and summarized the changes in the budget over time from the 2008-2009 academic year to the 2015-2016 academic year. This report will be made available to the faculty.
 - b. President Mahony reported that presently the state had appropriated no new revenues to Winthrop as well as to other state universities.
 - c. President Mahony said that the state would raise the costs for pensions (2%), which would have the impact of a \$1 million dollar budget cut.
 - d. President Mahony said that after meeting with the Academic Freedom and Tenure Committee that we would begin to amend our tenure and promotion guidelines to make the process more transparent.
 - (At this time John Bird announced that we now had a guorum).
- V. Report from Provost/VP for Academic Affairs, Dr. Debra Boyd
 - a. Dr. Boyd announced that 24 faculty searches were underway as well as two dean searches.
 - b. Three candidates for the Dean of the College of Business would be on campus next week, and CPVA dean candidates would come the week after spring break.
 - c. Dr. Boyd thanked everyone who worked on the current search committees.
 - d. Dr. Boyd thanked us for submitting midterm grades and emphasized the importance of midterm grades.
 - e. Dean Gloria Jones, University College, emphasized talking to students about options.
 - f. Dr. Boyd thanked everyone who participated in the SACS 5th year report.
- VI. Academic Council Report, Dr. Dave Pretty
 - a. Dr. Pretty stated that we needed to vote on nine new programs and that there were three program changes that required no vote.
 - b. Seventy-seven course proposals were approved unanimously with no questions.
 - c. Dr. Pretty presented the General Education courses that were proposed for certification. All were approved without questions.
 - d. Dr. Pretty presented the General Education Courses that had been approved for recertification.
 - e. Dr. Pretty announced that the next Academic Council meeting would take place on Friday, April 7.

- The election was held for the next Chair of Faculty Conference.
 Dr. Dave Pretty (History) and Dr. Mike Lipscomb (Political Science) made excellent statements about why they would be good Faculty Conference chairs.
- 2. The faculty voted for Faculty Conference chair as well as other standing committee positions.
- b. Rules Committee, Dr. Andrew Besmer
 - 1. Dr. Bessmer presented an amendment to Article VII, Section 6 of the Faculty Manual, which gives the Parliamentarian the duty of notifying faculty of election results instead of the Secretary. The amendment passed unanimously.
 - 2. Dr. Bessmer presented changes to Article VIII Section I and II, which deal with tenure and promotion committees. The faculty voted to vote on these during the April 14 Faculty Conference meeting.
 - 3. Dr. Bessmer presented a recommendation pertaining to Article XI of the Faculty Manual, which changes the bylaws to match current practice.

The following proposed policy change for the Committee on University Petitions was approved by Academic Council without dissent and requires Faculty Conference approval.

General Appeal Procedure (proposed)

The General Appeal Procedure applies to students who are seeking variations from General Education requirements and other university-wide academic regulations. The policy, which is found in the Winthrop University Undergraduate Catalog, 2009-10, page 10, reads as follows:

Any undergraduate student may appeal for variations in the general education requirements and other university-wide academic regulations by submitting a typed petition to the Committee on Undergraduate Petitions.

Petitions must be accompanied by supporting statements or other documentary evidence which the student judges pertinent to the petition. Petitions should be addressed to the Committee on Undergraduate Petitions, in care of the Registrar, and should include the student's name, student number, address, major, class, telephone number, and name of adviser. A petition form is available in the Office of Records and Registration.

To be considered at a regular monthly meeting, petitions must be received by the Registrar at least one week prior to the published meeting date of the Petitions Committee.

For petitions concerning a lapse in course inclusion within the General Education Program, the Registrar reserves the right to review and act on the petition and relay the decision to the student and the Undergraduate Petitions Committee. For all other petitions, the Registrar forwards the petitions, along with any supporting documents, to the Undergraduate Petitions Committee and relays to the student the decisions reached by the Committee.

The following proposed revision of the requirements for a general education natural science course was approved by Academic Council without dissent and requires Faculty Conference approval.

Changing the language in the 2016-17 Undergraduate Catalog under "Degree Requirements," p. 15:

Goal Five: To understand scientific knowledge in terms of its methods or acquisition, its specific quantitative nature, and its dynamic and contingent character.

To achieve this goal, students should:

- 1. Study important concepts and areas of science that may affect everyday life;
- 2. Identify and develop hypotheses, design studies, and collect data in light of these hypotheses;
- 3. Take accurate measurements and make detailed observations to reach valid empirical conclusions;
- 4. Understand how scientific theories change over time; and
- 5. Recognize reputable sources of scientific information.

Learning Objectives (from the online application on the University College website)

No one course can meet all of these objectives simultaneously. However, to be considered for this category, at least three items from items 2-7 in the following list of objectives must be met in the course and clearly specified on the syllabus.

- Students will be conversant with a few fundamental concepts from among the three main areas
 of natural science, including earth, life, and physical science. (Committee comment: The
 wording "a few" seemed extremely vague and imprecise to us so we removed it.)
- 2. Students will be able to apply the scientific methods of inquiry. (Committee comment: Specifically addresses ULC 1 in terms of collecting and using evidence to solve problems.)
- Students will be able to identify and discuss the strengths and limitations of science, including sources of reputable scientific information. (Committee comment: Also addresses ULC 1 on critical thinking and seeking out and assessing relevant information.)
- 4. Students will be able to demonstrate an understanding of the history of scientific discovery.
- 5. Students will be able to discuss the social and ethical contexts within which science operates. (Committee comment: Addresses ULC 2 in reference to social responsibility and integrity.)
- Students will be able to communicate about scientific subjects including (lab courses only) the
 defense of conclusions based upon one's own observations. (Committee comment: Addresses
 both ULC 4 on effective communication and ULC 1 on the use of reliable evidence.)

7. Students will be able to discuss the application of scientific knowledge to the social sciences and to nonscientific disciplines. (Committee comment: Addresses ULC 3 on interconnectedness.)

Criteria for Inclusion (again from the application form):

"Natural Science Component courses are required to meet each of the following criteria. Briefly but clearly explain how the proposed course meets each criterion.

- 1. All included course must clearly demonstrate throughout the course that historical perspective is its primary focus.
- 2. All included courses must explicitly support the first learning objective identified above: 'Students will be conversant with fundamental concepts from among the three main areas of natural science, including earth, life, and physical science.' Clearly confirm that the proposed course supports this objective and identify the fundamental concepts in question.
- 3. Included courses must explicitly support at least <u>three</u> additional learning objectives listed above (among objectives 2 through 7). Clearly identify the objectives supported by the proposed course and the means by which meeting these objectives will be assessed.
- 4. Natural Sciences component courses must include a writing component: a single paper or combination of assignments totaling eight pages of evaluated writing or at least four evaluated assignments as defined by Faculty Conference on Dec. 2, 2016. How will the proposed course meet this requirement?"

The following proposed revision of the requirements for a general education historical perspectives course was approved by Academic Council without dissent and requires Faculty Conference approval.

- 1. Must clearly demonstrate throughout the course that historical perspective is its primary focus
- 2. Enable students to demonstrate an understanding of history that emphasizes
 - 1. the dynamics of **cause and effect** in historical events and concepts
 - 2. the ways that **change and continuity** influence human experience
 - 3. the **historical significance** of people, places, events, and concepts, including **diverse** cultures, intellectual **viewpoints**, **and aesthetic milieus**
- 3. Enable students to recognize that different conceptions of historical events and concepts exist. This must include:
 - 1. an understanding of how interpretations of history have changed over time
 - 2. an understanding of how **sources** are employed and interpreted in different contexts to develop an understanding of history
 - 3. an ability to recognize sound and unsound historical reasoning
- 4. Include a writing component that requires either a single paper or combination of assignments consisting of eight (8) pages of evaluated writing (normally two thousand [2000] words) or at least four (4) evaluated assignments. The writing component should be weighted enough that a student would not be able to receive a passing grade in the course without making a legitimate effort to complete the required written work.

C) Honor Code and Honor Pledge Subcommittee

Academic Council forwards this report to Faculty Conference with a request to the Chair of Faculty Conference to establish by the end of this academic year a working group to refine and implement this proposal.

The Honor Code and Honor Pledge Subcommittee of Academic Council met on April 4th, 2017, to discuss possible recommendations for implementing the Honor Code and Honor Pledge approved by Academic Council last year (in September 2015). The subcommittee members included faculty members Alice Burmeister, Marguerite Doman, and Kristen Abernathy, as well as Beth West (CSL President), and Bethany Marlowe (ex-officio). Dr. Abernathy was unable to attend the meeting, but was sent a copy of this report and gave her approval of its content. While brainstorming possible strategies for implementing the Honor Code and Honor Pledge, the subcommittee members came to the conclusion that implementing either an Honor Code and/or an Honor Pledge on its own, without the development of accompanying initiatives designed to support their implementation, would not be sufficient to create an expectation of academic integrity across the campus community. We therefore recommend the creation of a Standing Committee on Academic Integrity under the authority of Faculty Conference to consider the implementation of an Honor Code and/or Honor Pledge, in addition to related supporting activities of the kind described in the proposal below.

Proposal to create a Standing Committee on Academic Integrity, under the authority of Faculty Conference:

We propose the creation of a Standing Committee on Academic Integrity, to be made up of the following individuals: One faculty member from each of the four colleges (Arts & Sciences, Business Administration, Education, and Visual and Performing Arts) and a faculty member from Dacus Library; the Dean of Students (ex-officio); and the President of the Council of Student Leaders.

The charge of this standing committee would be to propose and develop initiatives designed to help create and maintain an expectation of academic integrity in the Winthrop University community. This would include: 1). Evaluating the effectiveness of university policies and current practices related to academic integrity, and proposing changes and improvements to these practices/policies where needed; 2). Developing training sessions and other support resources for full-time and adjunct faculty members to assist them in dealing with the challenges of maintaining standards of academic integrity for our current generation of millennial digital native students, as well as for themselves as scholars and educators; and 3). Developing training sessions and support resources for students to help them understand what academic integrity is and why it is important. In particular, students will be encouraged to understand how honoring Winthrop's standards of academic integrity will help them to be more successful, both as Winthrop students, and in their future lives after graduation.

2) New Business

Academic Council approved these changes without dissent and forwards them for Faculty Conference approval.

Proposed new language for policies related to

- 1) Accelerated Graduate Programs
- 2) Undergraduates taking graduate-level coursework
- 3) Transfer Credit

I. ACCELERATED PROGRAMS DEFINITION

Accelerated Programs

Winthrop offers a select number of accelerated programs that allow students to earn both a bachelor's and a master's degree in a shortened period of time. For example, a student in an accelerated program may be able to complete both degrees within five years and take a slightly reduced number of credit hours. Students should consult current undergraduate and graduate catalogs for more information regarding which accelerated programs are currently offered. When offered, these programs fall into one of the following categories:

4 + 1 Programs of Study

4 + 1 programs are institutionally-approved and highly-structured programs of study for Winthrop University students to earn both a bachelor's and master's degree in five years (4 years as an undergraduate student; 1 as a graduate student). In these programs, the undergraduate curriculum is intentionally designed to include specific pre-requisite courses required to pursue a 1-year master's degree program at Winthrop. A student will take specific upper-level undergraduate courses that 1) satisfy the undergraduate degree requirements and 2) prepare the student to enroll in the required graduate courses immediately upon undergraduate degree completion and complete the graduate degree in the prescribed efficient manner.

Combined Bachelor's/Master's Programs of Study

Combined bachelor's/master's programs are institutionally-approved and highly-structured programs of study designed for Winthrop University students to earn both a bachelor's and master's degree in five years. In these programs, a student will take specific graduate-level courses for graduate credit while still enrolled as an undergraduate student, thus reducing the number of graduate courses required for the graduate degree upon undergraduate degree completion.

Full Admission to Graduate School

Students must meet all graduate program admission requirements, as described in the Graduate Catalog, to be fully admitted to the Graduate School. Students pursuing a Combined Bachelor's/Master's or 4 + 1 program will not be fully admitted to the Graduate School until all undergraduate degree requirements are met. Completion of the *Intent to Pursue Combined Degrees Program* form and undergraduate review processes is not a guarantee of admission to the Graduate School. (See policy on "Undergraduate Students Taking Graduate-Level Coursework.")

Awarding of Degrees in Combined Bachelor's/Master's and 4 + 1 Programs

Students pursuing Combined or 4+1 programs will be awarded their bachelor's degree within one semester of completing all undergraduate requirements and at least one semester before the master's degree is awarded. The time allowable between undergraduate and graduate degrees may vary by program. Students should consult the Graduate Catalog or contact the Graduate School for specific admission requirements.

II. UNDERGRADUATE STUDENTS TAKING GRADUATE-LEVEL COURSEWORK

Winthrop Seniors

Winthrop seniors with an overall Winthrop GPA of 3.0 or higher may be permitted to take courses numbered 500-599 for graduate credit during their final semester of undergraduate work, provided the total course load (undergraduate and graduate) for that semester does not exceed 16 hours. Students may receive graduate credit for these courses only if the requirements for the undergraduate degree are satisfactorily completed by the end of that semester. Winthrop seniors with a GPA of 3.0 seeking to pursue graduate-level coursework during their final semester must:

 Complete the Request to Take Course for Graduate Credit form through the Office of Records and Registration (126 Tillman) no later than the add/drop deadline.

Undergraduate students who wish to take courses for graduate credit must receive specific approval from the academic dean of the college in which they are majoring.

Senior business students in their final term may take one 600-level business class if the student meets the following conditions:

- 1. Admitted to any Winthrop MBA program;
- 2. Limited to one 600-level business course;
- 3. A 3.0 undergraduate grade-point average; and
- 4. Limited to maximum load of 16 semester hours.

Undergraduate Students Pursuing Combined Bachelor's/Master's Programs

Undergraduate students who are pursuing Combined Bachelor's/Master's Programs of Study may qualify to take up to 9 hours of graduate 500-level coursework at Winthrop and apply those hours to the undergraduate degree. To qualify for graduate-level coursework in a combined bachelor's/master's program, an undergraduate must:

- Complete the Request to Take Course for Graduate Credit form through the Office of Records and Registration (126 Tillman) no later than the add/drop deadline;
- Submit an *Intent to Pursue Combined Degrees Program* form with the appropriate graduate program office (by that program's posted deadline) and have it approved by the specific graduate program director;
- Maintain at least a 3.0 GPA as an undergraduate; and
- Successfully complete 75 credit hours before taking each graduate course.

III. TRANSFER CREDIT POLICY

Winthrop may credit 9 semester hours of graduate work from another regionally accredited graduate institution or graduate work completed as an undergraduate at Winthrop toward a graduate degree, upon recommendation of the appropriate advisor and academic dean. An

additional 3 semester hours may be transferred from another regionally accredited graduate institution, at the discretion of the advisor and academic dean.

Students in a Winthrop combined bachelor's/master's program may apply a maximum of 9 graduate credit hours taken while an undergraduate to the graduate degree, providing a grade of B or better was earned in each course. All classes taken for graduate credit while an undergraduate at Winthrop will apply towards the graduate GPA, but may not apply toward the graduate program of study.

Transfer of credit must be approved in writing by the student's advisor and academic dean for inclusion in the student's official program of study, and the course level must be verified by the Office of Records and Registration. After a student has entered a graduate program at Winthrop, permission from the student's advisor and academic dean is required prior to enrolling in the transfer course(s). Approval to Transfer Graduate Credit forms are available online at www.winthrop.edu/graduateschool/forms. Official copies of transcripts must be submitted and evaluated before any transfer credit may be officially accepted. Certain courses submitted for transfer may not be considered equivalent to specified requirements, although course titles may be the same.

A graduate student may not transfer credit taken at another institution while he or she is on academic probation at Winthrop or is ineligible to return to Winthrop. Credit earned at another institution by a graduate student in good standing may be transferred if:

- 1. A grade of B or better has been earned in the course; or
- 2. A grade of S is earned; the granting institution is regionally accredited and would allow the course to be used in one of its graduate degrees.

Transfer credits are not used in computing the student's cumulative GPA.

Extension courses offered by accredited graduate institutions are subject to approval of the student's advisor and academic dean. Correspondence courses are not accepted for graduate credit. Transfer credit is subject to all Catalog regulations pertaining to graduate degree courses, including the 6 year time limit.

It is the student's responsibility to have an official transcript of the transfer credits forwarded to the Office of Records and Registration, 126 Tillman Hall, Winthrop University, Rock Hill, SC 29733, no later than four days prior to the expected graduation date. Transfer credits taken during the final semester of a program may delay graduation and certification approval until official transcripts have been received by the Office of Records and Registration.

Re: Committee Report, 2016-17 year

Academic Freedom & Tenure has been working with Faculty Personnel and Rules Committees for the last two years to revise some policies and procedures related to their charge. Specific changes include:

Policy changes—to be voted on April 14th by faculty body:

- Add promotion grievances to charge of Academic Freedom & Tenure, and remove those grievances from the charge of Personnel Committee
- Change name of Academic Freedom, & Tenure to **Academic Freedom, Tenure, and Promotion Committee**
- Remove Provost or other person from review of grievances if that person has been part of original tenure or promotion review process
- Include timeline for administrative review of committee report following a review of grievance or appeal.

Procedural changes—not requiring a vote, but to be shared with faculty April 14th, 2017

- Adopt procedural guidelines for hearing grievances from the existing language in Personnel Committee charge:
 - Specific information about where and how to file grievances for faculty
 - o Procedures for conducting a grievance investigation
 - o Time requirements for committee action and administrative decision/review

Note: Committee will continue to work with administrative and faculty groups to develop more clarity of guidelines about the work of the committee.

The Faculty Committee on University Priorities met with President Mahony on November 22, 2016. We submitted the following items as priorities for the university.

- 1. Improving the efficiency and effectiveness of processes, procedures, and decision-making at all levels of administration.
- 2. Ongoing consideration of concerns regarding the adoption of Wiley for online programs, and improving clarity as to the mechanics, cost, and implementation.
- 3. Addressing the lack of full-time faculty to adequately cover core courses in our General Education Program.
- 4. Improve understanding and implementation of accessibility policies and procedures regarding students.
- 5. Continue efforts to develop a university-wide strategic plan for recruiting that enhances effectiveness by improving communication between faculty, administration, and the admissions staff.

Proposed Bylaws Changes

Rules Committee

Andrew Besmer, Chair

The following proposals were presented to Faculty Conference at the February 24, 2017 meeting and moved to be placed on the agenda. Amendments to the bylaws must pass with a 2/3 majority.

Prohibition on Serving at Multiple Levels

Article VIII – Standing Committees of the Faculty Conference

Section 1 Academic Freedom and Tenure.

....

Section 2 Faculty Personnel. This committee shall be responsible for recommendations to the Faculty Conference concerning membership beyond those members indicated in Article III in these Bylaws; for recommendations regarding procedures and conditions of elections and the staggering of terms of office on appropriate committees and councils; for nominations of at least two qualified persons for each office subject to election by the Faculty Conference, except as elsewhere provided; for advice to the President and the Vice President for Academic Affairs concerning promotions in academic rank and the granting of tenure; and for performing the duties of a faculty grievance committee except in the granting of tenure.

The committee shall consist of three members elected at large by the Faculty Conference and one member elected by the faculty assembly of each major academic division. All members of the committee must be tenured. While serving on the committee, a faculty member shall not be eligible for consideration for promotion. Service on the Committee, a constituent faculty assembly's personnel committee, or a department's personnel committee is mutually exclusive. However, if a faculty assembly which includes departmental level review committees is unable to form a departmental personnel committee that includes a sufficient number of tenured members from that department, simultaneous service of not more than one member shall be permissible within the department personnel committee and the parent faculty assembly personnel committee only. Administrative Officers and department chairs shall be ineligible to serve on the committee.

Matching Curriculum Action Process to Bylaws

Article XI – Curricular Review

Section 1 Process for Approving Matters Relating Only to Undergraduate Curriculum.

Curriculum recommendations shall be reported to the Committee on University Curriculum. If all members of the committee agree that the recommendation is consistent with University-wide policy and does not infringe upon the legitimate interests of any other academic division, the committee shall vote to approve the recommendation, with the following exceptions:

- a. If the recommendation is for
 - i. Renaming a course
 - ii. Changing a course description
 - iii. Adding a course designator
 - iv. Changing a course designator
 - v. Dropping a course designator

In those cases, a vote is not required unless the recommendation is questioned. If the recommendation is not questioned then the recommendation shall become the action of the Committee on University Curriculum.

Such approval shall be communicated promptly in the report of the committee to the members of the Faculty Conference and shall be placed on the agenda of the Academic Council. If the committee is not unanimous in its approval, the recommendation shall be placed on the agenda of the Academic Council with a record of the committee's vote on the recommendation.

Academic Council shall review and vote on the recommendation, with the following exceptions:

- b. If the recommendation is for
 - i. Adding a course
 - ii. Dropping a course
 - iii. Renumbering a course
 - iv. Adding or changing prerequisites or corequisites to a course
 - v. Changing requirements for a minor
- vi. A recommendation in which a vote was not required of the Committee on University Curriculum and that committee's action was to approve the recommendation

then a vote is not required unless the recommendation is questioned. If the recommendation is not questioned then the recommendation shall become the action of the Academic Council.

Such approval shall be communicated promptly in the report of the committee to the members of the Faculty Conference and shall be placed on the agenda of the Faculty Conference. If all members of the committee are not in agreement, the recommendation shall be placed on the agenda of the Faculty

Conference with a record of the committee's vote on the recommendation.

Faculty Conference shall review and vote on the recommendation with the following exceptions:

- c. If the recommendation is for
 - i. Adding or dropping a minor
- ii. A change in graduation requirements for a major with no change in overall number of hours
- iii. A recommendation in which a vote was not required of the Committee on University Curriculum or Academic Council and both committees action was to approve the recommendation

A vote is not required unless the recommendation is questioned. If the recommendation is not questioned then the recommendation shall become the action of Faculty Conference.

Section 2 Courses enrolling undergraduate and graduate students. Any recommendation that:

- a. Renames a course
- b. Changes a course description
- c. Adds or drops a course
- d. Renumbers a course
- e. Adds or changes prerequisites or corequisites to a course
- f. Adds, changes, or drops a course designator
- g. Changes graduation requirements in a degree program with no change in the overall number of semester hours required by the program

and involves a course that enrolls both undergraduate and graduate students shall be reported by the college's curriculum committee both to the college faculty assembly and to the Graduate Council. If both of these bodies approve the recommendation, it shall be forwarded to the Committee on University Curriculum and shall be approved or denied in the manner described in the appropriate section of this article. If both of these bodies deny the recommendation, it is denied. If one of these bodies approves the recommendation and the other denies the recommendation, it is denied, but the Committee on University Curriculum may (but is not obliged to) suggest means for producing a recommendation that could be approved by both bodies.

Section 3 Teacher education courses. A recommendation that affects teacher education programs or courses used in these programs shall be reported to the Teacher Education Committee after it is approved by a college faculty assembly.

Of those recommendations, any recommendation that

- a. Renames a course
- b. Changes a course description
- c. Adds or drops a course

- d. Renumbers a course
- e. Adds, changes, or drops a course designator

shall be reported to the Teacher Education Committee for information purposes only.

All remaining recommendations shall be reported to the Teacher Education Committee for a review and vote. If the committee approves the recommendation, it shall be reported to the Committee on University Curriculum and shall be approved or denied in the manner described in the appropriate section of this article.

Section 4 General education courses. A recommendation that adds a course to the lists of courses meeting the core skill areas of the General Education program or modifies a course on these lists shall be reported to the General Education Curriculum Committee. If the committee approves the recommendation, it shall be placed on the agenda of the Academic Council. If the Academic Council approves the recommendation, it shall be placed on the agenda of the Faculty Conference. New courses must be added following Section 1 in this article before being reported to the General Education Curriculum Committee.

Academic Freedom & Tenure Committee

Section 1 Academic Freedom, Tenure, & Promotion. This committee shall be responsible for recommendations to the Faculty Conference with respect to policies on academic freedom, tenure, and promotion, shall serve as a hearing committee for cases arising under the procedures and policies on academic freedom, tenure, and promotion, and shall serve as a grievance committee in cases involving the granting of tenure or promotion. The committee also hears appeals in cases of post-tenure review. In its role as a grievance committee, it shall report its findings to the President and to the faculty member making the grievance. The President shall then evaluate the case in light of the committee's

findings and shall render a decision. If the President decides adversely to the faculty member, the faculty member may appeal the decision to the Board of Trustees. Should the President appoint a designee to act in his place during a review of tenure or promotion cases, the appointee must not have already been part of the tenure or promotion decision process. While the Board of Trustees may choose to receive such an appeal on the basis of improper procedure only, the Board affirms that substantive judgments reside and end with the President (Board of Trustees Resolution 11-15-96, Reaffirmed 11-6-07)

The committee shall consist of nine elected members. One member shall be elected by the faculty assembly of each major academic division (5), and four members shall be elected at-large by Faculty Conference. All members of the committee must be tenured. While serving on the committee, a faculty member who brings a hearing or grievance matter before the committee or who has been involved in the matter must recuse him/herself from deliberation on that case. Administrative Officers and department chairs shall be ineligible to serve. Eligibility shall be limited to faculty members with tenure.

Section 2 Faculty Personnel. This committee shall be responsible for recommendations to the Faculty Conference concerning membership beyond those members indicated in Article III in these Bylaws; for recommendations regarding procedures and conditions of elections and the staggering of terms of office on appropriate committees and councils; for nominations of at least two qualified persons for each office subject to election by the Faculty Conference, except as elsewhere provided; for advice to the President and the Vice President for Academic Affairs concerning promotions in academic rank and the granting of tenure; and for performing the duties of a faculty grievance committee except in the granting of tenure or promotion.

The committee shall consist of three members elected at large by the Faculty Conference and one member elected by the faculty assembly of each major academic division. All members of the committee must be tenured. While serving on the committee, a faculty member shall not be eligible for consideration for promotion. Administrative Officers and department chairs shall be ineligible to serve on the committee.
