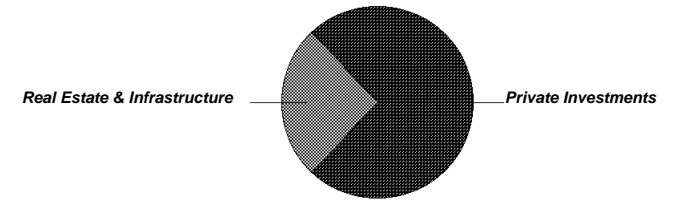

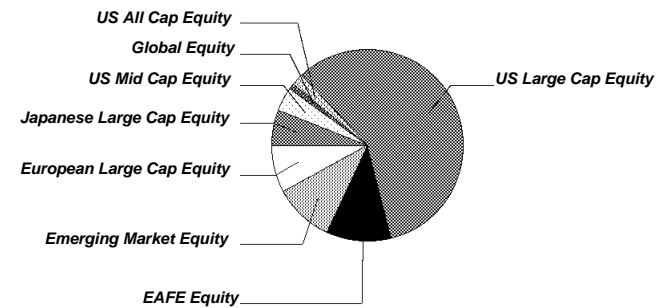

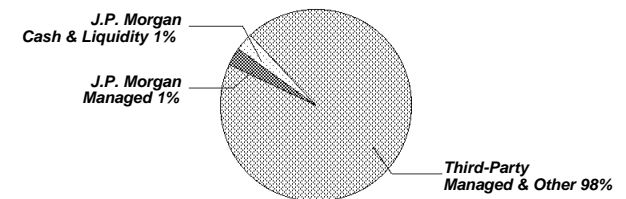
Asset Allocation

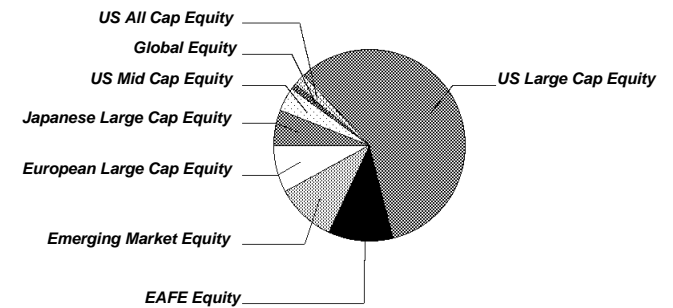

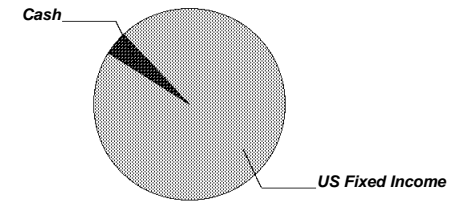
