Submit a verified copy of a current South Carolina State Department of Education Class III Certificate or the equivalent from another state.

2 Submit official transcripts (sent directly to Winthrop University from the issuing institution) for evaluation. Additional undergraduate course work may be required to strengthen the applicants academic credentials.

#### 2004-2006 Graduate Catalog (Effective Fall 2004)

Admission Requirements. Admission to the MEd middle level education requires the applicant to:

- 1 Submit a verified copy of a current South Carolina State Department of education Class III Certificate or the equivalent from another state
- 2 Submit official transcripts (sent directly to Winthrop University from the issuing institution) for evaluation. Additional undergraduate course work may be required to strengthen the applicants academic credentials.
- Have an undergraduate grade-point average of minimum 2.75 on a 4.0 scale in the last 60 hours of the student's undergraduate course work OR submit an official score of 900 or above on the combined verbal and quantitative portions of the General Test of the Graduate Record Exam (GRE).
- 4 Present two letters of recommendation to include a recommendation from the applicant's current principal, assistant principal, or other supervisor/professional educator.
