#### I. Minutes from February 11, 2022 meeting - approved in advance via email

#### II. Remarks from the Chair (Alice McLaine)

Dr. McLaine thanked the members. She noted we had solid year and that we served the university by providing feedback regarding critical budgetary issues. The empathy and depth of review provided by the group was extraordinary.

She indicated that the Council approved and sent forward to Faculty Conference several initiatives that make navigating degrees much more straightforward for students. Our ability to do this work is directly related to the efforts of Gina Jones and Tim Drueke to bring these concerns to us and for doing the research into the underlying issues. The level of detail provided by Gina on several of these initiatives was remarkable. She also thanked those who did significant work in their committees:

Dr. Martin—CUC (231 courses and 51 programs—very busy year for them). The professionalism and attention to detail this committee demonstrates is admirable and really an example of professional stewardship.

Dr. Tarabar—Gen Ed Curriculum Committee, provided a new mission statement and appropriately aligned intensive writing with the general education program. They revised the Student Learning Objectives for the general education components to make them measurable while still meeting the intent of the various area of general education. They also ensured that each component of general education is tied to at least one of the University Level Competencies.

Dr. Sellers—Gen Ed Assessment Committee. They developed a plan for assessing each component of the general education program on a defined schedule. They are immersed in the work of establishing thorough and appropriate assessment for each component of general education.

### Writing Certificate comparison research:

- Reviewed 9 peer or aspirational programs (Austin Peay State University, University of Minnesota Duluth, University of South Alabama, Kansas State University, Western Michigan University, East Carolina University, Auburn University, Weber State University, Bowling Green State University) with graduate writing certificates
- In 7 of 9 of these programs, one-third or more of their applications were for their writing concentrations
- Enrollments steadier in writing concentrations than in traditional MA programs
- Targeting students coming out of BA programs who are not inclined to pursue the full MA, but either certificate could be stackable to an MA



# Curricular Proposals & Policy Updates

- Program modifications:
  - Restructure methods courses to support transfer pathways and increase completion rates for existing students

- Full Degree Transfer policy

#### B. General Education Curriculum Committee (Danko Tarabar)

- 1. The new course proposal deadline for general education inclusion in 2023-2024 catalog is January 1, 2023.
- 2. The general education recertification process is put on pause for one more academic year 2022-2023). This means that all general education courses currently certified remain so in 2022-2023 academic year.
- 3. In 2023-2024 academic year, we will undergo recertification of the general education core (ACAD 101, WRIT 101, HMXP 102, CRTW 201), oral communication, quantitative skills, and founding documents.

Mr. Drueke asked about pre-reqs for MATH courses—wouldn't they already meet the QUAN? Dr. Hamm replied that MATH 201 was a pre-req and a student could have that as AP credit or have this as their first math course.

<u>Addendum 4/21/22:</u> CHEM117, Introduction to Environmental Chemistry (3 credit hours), was inadvertently left off the list of new general education offerings as a natural science option. The General Education Curriculum Committee approved it unanimously. AC approved via email on 4/21/22.

#### C. Cultural Events Committee (Matt Ferrell)

Recommendation to revise cultural events guidelines

Dr. Ferrell stated that some events approved in the past were not approved this year as members felt they were not abiding by the guidelines. There was much discussion about "culture" in the committee. Some events felt they needed CE status to get attendance. The revisions are merely clarifications. They are not changing the guidelines.

Voting done via Qualtrics survey. Revisions were approved.

#### **Second Baccalaureate Degree**

Appendix B

Requirements for completing a second baccalaureate degree are:

- 1. Meet all the major requirements for the second degree as determined by the Department Chair and Student Services Office in the college of the major.
- 2. Complete a minimum of 30 hours in residence beyond requirements for the first degree.

Cultural Events are not required for any second degree.

Students completing their second undergraduate degree after having completed their first degree at Winthrop do not have to complete a minor if seeking a BA degree.

The general education requirements completed in the first baccalaureate degree will meet the general education requirements for the second baccalaureate degree. Students may still need to complete needed course prerequisites for courses in the major.

Students wishing to complete a second degree concurrently with their first undergraduate degree must meet all requirements for the second degree and complete 30 credit hours beyond the requirements for the first degree (minimum 150 hours).

#### Rationale for change to the policy:

Some students who pursue a second baccalaureate degree will have a prior degree from a previous institution. Those degree programs already included the completion of a general education program. The current policy allows the college to specify the courses needed to complete the second degree. Usually, this would include any missing general education courses – specifically HMXP and CRTW, and sometimes a physical activity course. Most

students pursuing a second degree are changing careers and likely need at least 30 hours already. Additional general education courses create additional time to degree and cost for the student.

Earned and Unearned Fs. Appendix C

The Office of Financial Aid is encouraging Winthrop to create special grades in order to help track unofficial withdrawals. There are several schools that have this distinctive grade including USC-Columbia, USC-Aiken, and Lander. Clemson and Western Carolina allow instructors to drop students for non-attendance.

USC's policy specifically states that their grades FN (Failure-Non Attendance) and UN (Unsatisfactory-Non Attendance) are assigned to students who never attended or have stopped attending class but have not officially dropped or withdrawn. Faculty are required to provide a last date of attendance when assigning this grade. The grade and the last date of attendance are used in determining the recalculation of awarded funds for financial aid recipients. Reporting the last date of attendance is critical to avoid potential financial liability for the institution.

Per Federal Financial Aid guidelines, if a student who began attendance and has not officially withdrawn fails to earn a passing grade in at least one course offered over an entire period, the institution must assume, for Title IV purposes, that the student has unofficially withdrawn, unless the institution can document that the student completed the period. In some cases, a school may use its policy for awarding or reporting final grades to determine whether a student who failed to earn a passing grade in any of his or her classes completed the period. Schools may implement an official grading policy that provides instructors with the ability to differentiate between those students who complete the course but failed to achieve the course objectives and those students who did not complete the course.

Financial Aid audits occur every year and we are required to provide transcripts of a select group of students. Having the Unearned vs Earned **F** (or **U**) delineated on the transcript will demonstrate to auditors that we are tracking these students and applying financial aid appropriately.

The proposed grades are:

**UF**— unearned F; Failure due to non-participation/non-attendance (no quality points)

**UU**— unearned U; Unsatisfactory due to non-participation/non-attendance

A last date of attendance will be required for these grades.

#### **Current Grading System**

Grades for courses taken for undergraduate credit are recorded as follows:

- **A** Excellent, achievement of distinction (4 quality points per semester hour).
- A- (3.67 quality points per semester hour)
- **B+** (3.33 quality points per semester hour)
- **B** Good, achievement above that required for graduation (3 quality points per semester hour).
- **B-** (2.67 quality points per semester hour)
- C+ (2.33 quality points per semester hour)
- C Fair, minimum achievement required for graduation (2 quality points per semester hour).
- **C-** (1.67 quality points per semester hour)
- **D+** (1.33 quality points per semester hour)

- **D** Poor, achievement at a level below that required for graduation; must be balanced by good or excellent work in other courses (1 quality point per semester hour).
- **D-** (.67 quality points per semester hour)
- **F** Failure, unsatisfactory achievement (no quality points).
- **S** Satisfactory achievement (Honors courses, B level or above; all others C- level or above) on a course taken on a satisfactory/unsatisfactory basis.
- **U** Unsatisfactory achievement (Honors courses, B- level or below; all others, D+ level or below) on a course taken on a satisfactory/unsatisfactory basis.
- **N** No Grade, indicating the student withdrew from the course
- Incomplete, used only as a prefix to a letter grade. Assigning an incomplete grade indicates that, for a valid reason, the course has not been completed and that the instructor reserves the right to raise the grade if the incomplete work is completed within one year, or by an earlier date specified by the instructor. The grade to which I is prefixed is not used in computing the student's GPA until the I prefix is removed and indicates the grade earned if no further work is performed. It is the grade in the course unless and until changed by the instructor or until one year has passed, at which time the incomplete is converted to the default grade.

#### **Academic Forgiveness Policy Proposal**

Current policies:

#### **Academic Forgiveness Policy:**

At the time of readmission to Winthrop, a student who has been absent for five calendar years or longer may choose to reenter under the "academic forgiveness policy." Under this policy, all courses previously taken at Winthrop University are treated as if they were transfer credit from another institution for purposes of granting credit toward graduation. As with transfer credit, these earlier courses are not used in computing the student's grade-point average. However, all earlier courses and the grades earned remain on the student's official transcript and are counted in computing eligibility for academic honors. The student must exercise or waive the "academic forgiveness" option by the end of the first week of the second semester he or she is readmitted to Winthrop University. Students who have already utilized all their repeat exemptions do not get additional repeat exemptions.

#### Transfer credit policy:

Winthrop University, in general, accepts transfer course credit from other institutions of higher education under the following conditions:

- 1. The course work must have been taken at an institution that is accredited by the commission on colleges of a regional accreditation agency.
- 2. The subject matter and the level of the course must be appropriate to Winthrop's general education curriculum or the program into which the student is transferring.
- 3. The grade that is received for the course must be at least a C- or a grade with a minimum level equivalent to a C-.

#### Proposal to change the Academic Forgiveness Policy:

At the time of readmission to Winthrop, a student who has been absent for five calendar years or longer may choose to reenter under the "academic forgiveness policy." Under this policy, all courses previously taken at Winthrop University are treated as if they were transfer credit from another institution for purposes of granting credit toward graduation. As with transfer credit, These earlier previous courses are not used in computing the student's grade-point average. However, all earlier courses and the grades earned remain on the student's official transcript and are counted in computing eligibility for academic honors. The student must request exercise or waive the "academic forgiveness" through the Office of Records and Registration option before end of the first

week of the second semester he or she is readmitted to Winthrop University. Students who have already utilized all their repeat exemptions do not get additional repeat exemptions.

#### Justification:

Recently a student submitted a petition to include the courses forgiven in which they earned a grade of D. The petitions committee wondered why these courses were excluded. Currently under the Academic Forgiveness policy, all forgiven work is treated like transfer work, where only grades of C- or higher are accepted toward degree requirements. These courses do not count toward a student's grade point average. This means that any other student who takes a course at Winthrop and earns a D can apply that course to their degree program (if the D is acceptable for the course), but a student asking for Academic Forgiveness cannot use any course with a D towards their degree requirements. The current Academic Forgiveness policy allows any course with a C- or better to be counted in the degree program and the grade is removed from the GPA. It is appropriate, then, that Academic Forgiveness be applied to <u>all</u> credits, and <u>all</u> courses with a passing grade be allowed to apply to the degree, unless the degree requires a specific grade. Losing credits is never in a student's best interest.
