I. Minutes from the April 8, 2022 meeting

Winthrop needs to get out of the reactionary mode we've been in over the last several years due to a number of factors. He also is trying to avoid the word "pivot." Every other week we seem to be doing something differently. He wants to get us back to doing what we do best, and this committee can help shape that.

V. Old business

A. Cultural Events Committee Update

1. Recommendation to revise cultural events guidelines

Dr. McLaine remarked that at the last Faculty Conference, faculty were upset over the guidelines. There had been some events denied that had been approved previous years. Dr. McLaine is pulling together a group to look at the guidelines. She noted that there were some differences from what was on the website and the proposed guidelines. The goal is that this will come to this committee again with a more robust justification. She indicated that the policy itself was straightforward and not controversial so there may have been concern about the policy not being followed.

VI. New Business

Dr. McLaine mentioned that there is a need for a CUC chair and she asked the group if there was anyone interested. Mr. Drueke explained what the chair's duties would be. He said that the new curriculum system would move some of the work into the system itself. Dr. McLaine indicated that Kara Traverse, secretary, had things organized.

Mr. Drueke talked about some things being discussed in the Provost's office regarding curriculum. He referred to a discussion last year about exploring doctoral programs such as the EdD now that the state is allowing comprehensive universities to offer them.
