Modify course: Change prerequisite from “Educational Studies minors or graduate standing in MAT program” to “Must be admitted to Teacher Ed or enrolled in Master of Arts in Teaching;” Restrict course to one of following degree programs: Master of Arts in Teaching, Secondary Social Studies Concentration; BA in Social Studies Education; Educational Studies Minor.
SOCL302	302. Social Theory (3).	Modify course: Change terms offered; Update prerequisite from “SOCL201 or SOCL101 or ANTH201 with C- or better. Open only to Sociology Majors/Minors, Criminal Justice Minors and Anthropology Minors” to “SOCL201 or SOCL101 or ANTH201 with C- or better.”
THRT395	Production Practicum in Theatre	Modify course: Change course title from Special Topics in Theatre; Update catalog description and whether the course has a final exam; Change number of times students can receive credit from 5 to 6; Add “THRT 115, THRT 110, THRA 180” as the prerequisite and that students need instructor permission to register.
THRT495	Capstone Production Practicum	New course
