I. Minutes from February 10, 2023 meeting

Dr. McLaine welcomed everyone. She asked for a motion to approve the minutes. There was no discussion and they were unanimously approved.

II. Remarks from the Chair (Alice McLaine)

We had a lot of policy updates last year which helped this year. She thanked Tim Drueke and Gina Jones for their assistance and the curriculum committee for their work. Due to the late CourseDog curriculum system implementation, a lot of curriculum was done in the last two curriculum cycles: 32 program changes, 16 minors, 205 courses—which is a little less but was done in two meetings.

III. Remarks from the Provost and Executive Vice President for Academic Affairs (Peter Judge)

Dr. Judge thanked everyone for their work this year. It's been a pretty calm year but still some important work being done. He is appreciative of Dr. McLaine's work on Academic Council as well as stepping in to FC chair and coordinating the Provost search. He is glad to see Dean Slack's proposal.

Dr. Matthews asked about faculty being able to see the program health information. Dr. Judge said that there is a meeting scheduled in a couple of weeks, but they are working on a way to make program information available to departments. Dr. Matthews says better transparency

and the more we know, the better. He also thanked Dr. Judge for filling the Provost role this year. Dr. McLaine said it had been a pleasure working with him.

IV. Remarks from the President of the Council of Student Leaders (Miguel Caldwell)

Internship responsibilities kept Mr. Caldwell from attending. Dr. McLaine said we need to work on getting a substitute when the President cannot attend.

Mr. Drueke talked about some of the cross-listing of major courses to accommodate students in both programs. Regarding the marketing minor, the actual courses were removed to allow flexibility whenever the COB may update the minor. Regarding the tracks in MCOM, these are pretty significant re-writes.

Dr. Whitney indicated a concern about hidden pre-reqs for design courses. CUC approved by a slim margin.

Dr. McLaine will send out a Qualtrics survey for voting.

Dr. Matthews talked about hidden pre-reqs. He indicated that the College of Business got rid of their hidden ones. It's not fair to students. He understood that the chairs of Design and MCOM were in conversation. Mr. Drueke indicated that there wasn't necessarily a content-related pre-req needed, but we need some clarification.

Dr. McLaine said we certainly want to protect students from hidden pre-reqs, but this proposal came through without the details being worked out. It was suggested that we delay voting until clarifications are made.

C. General Education Curriculum Committee (Kelly Costner)

Dr. McLaine reminded everyone that we had paused GE certifications this year but it will resume next year.

Dr. Costner went over the course information.

Dr. Bloomquist asked about the X course. Mr. Drueke said it was offered for the first time this semester. Students would be able to get credit for it.

Course was unanimously approved.

D. General Education Program Director (Kelly Richardson)

Dr. Richardson is still trying to transition into this new role. She is meeting with various folks to wrap her head around what the role means as well as locate forms! She wants to have a clear plan by fall.

E. Report from Academic Integrity Committee (Alice Burmeister)

Policy proposal regarding academic integrity violations. This is informational and will act on it in the fall. Mr. Drueke said that this doesn't not require a vote as this is a conduct issue, not an academic affairs policy. Dr. Burmeister said that was good to know. She said she's been on this committee for a number of years. She said that students want expectations clarified. She went over the current process and some of the challenges with it. She then

went over the proposal. She also talked about an online module (RAISE?) that would explain academic expectations. Dr. McLaine said some of this is in ACAD. Dr. Burmeister said the module would reinforce this. She said it was pretty straightforward. Mr. Drueke said having this outside ACAD would catch Grad students and incoming transfers who don't take ACAD.

Dr. Burmeister mentioned a program for catching AI generated work. She said further discussion is needed. She questioned how to communicate to students about the responsible use of AI.

Mr. Drueke said there should be further discussion about the form for reporting academic misconduct. Maybe Navigate?

Dr. Bloomquist thanked Dr. Burmeister for bringing this policy forward. She also asked about training especially dealing with AI.

Mr. Drueke indicated that there is a GR policy on academic misconduct, so this proposal would need to go to GR Council.
