- V. Report from the Graduate Dean, Jack DeRochi (JD): New graduate enrollment for Fall 2021 is up again for degree-seeking = 1031. Sustainable online programs establishment and even on campus programs and our ability to serve these students is the reason why enrollment is up. Many admission requirements have changed due to COVID, such as getting rid of the GRE, has also helped. New online suite of programs is rolling out despite some bumps along the way (MS Nutition and MEd Literacy). Special Ed licensure track may be in the works for the next suite. Tuition rates for the online programs are under review and will be brought forward for discussion and approval by the BOT. Graduate Faculty Status may become an administrative function so that it is linked to faculty credentialing when they are hired. Be communicators to your colleagues and students in your department. Be advocates for graduate education within your departments and divisions. Kori Bloomquist (KB) asked if there was discussion on an increase or decrease in tuition for online programs? JD: Decrease, but nothing is set in stone. There is a big difference between being new to the school vs. new to the market. We must price the program to maintain excellence but also sustain enrollment in a market.

- a. Brief Update on GC digitalization:
 - 1. Review of the petition process; Attempts to streamline. Now found on Teams Under "Files for Committee Review" in the General Graduate Council Team folder, click on "Files" on the top navigation bar, and the list of folders for each

meeting will populate. Prior to each meeting, all agendas, GFA applications and petitions will be in the corresponding folder. Any petitions for immediate review will be in the "Immediate Review" folder and then later moved to their corresponding meeting folder for documentation purposes. April Hershey (AH): There is work afoot to get the petition form digitized to include signatures and an automatic workflow based on Banner populated information. We hope that this new process will be rolled out no later than spring 2021.

Specifically, they would like to use EDUC 650 and EDUC 651 from the old MED in C&I to substitute for LTEC 645 and LTEC 646, (respectively) in their current M.Ed. in Learning Technology. TG: Spoke with Marshall Jones. All of the content in the old classes is now in the new courses. The student has gotten the new content through the CofC certification courses. LF: With Marshall Jones' approval, this meant a lot. SB: Motion to approve. TD: 2nd. Approved.
