 Motion to approve: NM (Nicholas Moellman). Second: SS (Stephanie Sutton). Approved by acclimation vote.
- III. Report from the Graduate School Dean, Jack DeRochi
 JD (Jack DeRochi): wondering if there was a connection to the briefness of the last
 meeting as I wasn't there. That was just a month ago and I had submitted a report.
 Also you would have heard it if you were at GFA. Essentially enrollment fall to fall
 was down 10%, spring to spring is down 10% as well. Seeing some indications that
 the graduate school enrollment market is quickening. More activity for campus based
 and online. We have two new cohorts, in the College of Education, Sport and Human
 Sciences, with Counseling and Ed Leadership. Wiley is being acquired by Academic
 Partnerships, if you saw that in the news. This will not affect our partnership, but may
 actually help to broaden our work. Final note, I did tell this body in that report, the
 renaming/rebranding will happen over the spring but doesn't affect graduate faculty
 governance. This is just a school for housing those faculty who serve adult students.

- V. New Business None DH: I don't have anything aside from moving our next meeting to zoom.
- VI. Curriculum action Please review these prior to the meeting by logging into Coursedog

DH: you can always go to Coursedog to review these but I'll also send the pdf as well. Glad we have a few business folks so they can help clarify some of these items.

We have two modify programs, so I think we can vote on those together. They are both on business.

Curriculum Changes Requiring a Vote:

- 1) Modify Program: Master of Business Administration in Business Administration DH: in summary, allowing for more electives that should make the degree more flexible to help with matriculation. Keeps folks graduating.
- 2) Modify Program: Master of Science in Accounting and Analytics DH: believe it is just a name change to incorporate the STEM designation. There does seem to be interesting marketability notes on there. Would make us one of the only programs in SC. ECR (Edward Charles Randle): that's a good summary. I am Accounting. There is a national change, moving to more classified STEM. There are more federal initiatives focused on the STEM. We'd be the first, definitely not the last, in SC. The world is moving that way. NM: allows international students to add an additional year on their visa. Something we've also talked about with undergrad as well. Hoping to help attract international students.

Motion to approve: SH (Sherry Hoyle), Second: SS / TS (Tony Strange). Approved by acclimation vote.

- 3) Edit Course: BIOL 513 Organic Evolution
- 4) Edit Course: ENTR 579 Business Plan Development

DH: both of these are updating the prerequisites to reflect current course offerings. But I don't think it affects anything in current grad offerings, just for undergrads in 500 level. GJ (Gina Jones): there were a few errors that I corrected. I added justification. And clarified the prerequisites were directly related to undergrad.

Motion to approve: NM, Second: SS. Approved by acclimation vote.

5) Create New Course: MGMT 583 Logistics and Distribution Design, Implementation, and Analytics

DH: I noted that on the prerequisites it didn't state graduate status, so that should be added. At least on Coursedog last I looked. In the past we've approved with that change in mind. GJ: I can update that. DH: this was a good justification, reflecting Grey data that this was a course of interest of folks and meets market demands. SS: does it matter that the course level is still showing as undergrad? I'm looking at the first page, course level is undergrad. GJ: will touch base with

Karen. DH: so long as those changes are reflected, I think we can still vote to approve.

Motion to approve: ECR, Second: SS. Approved by acclimation vote.

VII. Graduate Petitions – None

JD: do you all meet for last minute petitions in December as well? GJ: there usually is something on reading day that comes through. LH (Lisa Harris): we've done them virtually in the past. JD: great, I just want everyone to be aware of those last minute petitions. And I do have another note to make. We have secured a digital licensing program for digital badges that integrates with Blackboard Ultra. We have worked through new procedures for digital badging as it relates to micro certificates. It makes visible professional competencies. This body will have the opportunity to review that policy. We're really excited. Allows student to showcase their skills. DH: thank you for the reminder of the petitions. We were doing a lot over the summer and Jennifer had handled them over email. I'll try and follow in her footsteps. CW (Chris Ward): we'll have one. TS: we'll have two.
