- The Department of Theatre and Dance will present the annual **Winthrop Dance Theatre** performances November 9-12 in the Johnson Theatre. **Winthrop Dance Theatre** offers a full evening of exciting dance works choreographed by faculty and guest artists and is a highlight of *Homecoming Weekend*.
- *Steel Magnolias* (the basis for the much-loved multi Oscar-nominated film) is the bittersweet story of six women who gather under the dryers at Truvy's Beauty Salon to share gossip, laughter, recipes and beauty secrets on four significant days across three years of their lives in a small US Southern town. When tragedy strikes, they face it with sass and strength, supporting each other through thick and thin, by turns hilarious and poignant, *Steel Magnolias* is a heart-warming portrait of friendship and love.

ADVISING TIPS

- You can also email Student Services (fredericksa@winthrop.edu) if you feel a student needs assistance in any area or is struggling in the major. I can determine what campus resources are most appropriate for the student.

ACADEMIC POLICIES

- **Course Overload.** Students who want to register for more than 18 hours in the next semester will need to wait until grades for the current semester are posted. If their cumulative GPA after the current semester is a 3.0 or better, they will be allowed to register via Wingspan for up to 21 hours. If the GPA is below 3.0, the student will need to submit a *University-wide Undergraduate Petition*, unless it is the student's final semester. In that case, the student should come to my office for assistance. Students have until the end of the first week of classes to adjust their schedules.

GENERAL EDUCATION

- **The approved list of courses that can fulfill general education requirements is updated each year.** Encourage students to sort by the “**attribute**” in Course Offerings in Wingspan, which means the type of requirement that course meets. This is the easiest way to ensure the class is meeting the intended requirement. In addition, the student can confirm in Degree Works after registered.

DEGREE WORKS

- Use Degree Works *along* with Department Checklists to advise students. Degree Works will help with general education and university requirements, while checklists help with planning and course sequences within the major. Students should also check Degree Works after they have registered to make sure courses are appropriately applied.
- Degree Works has the “What If” feature so a student can see how requirements change if a different catalog year, degree, major, minor, or concentration is selected. The GPA term calculator will help the student determine the potential GPA at the end of the semester.
- Use Degree Works to record suggested courses for your advisee instead of paper. Click on the Planner Tab, select a term on the right-hand side of the page, and simply drag and drop courses from the worksheet to the term plan. Type a name in the description field, click the LOCK box as well as the box beside the term, and then click SAVE PLAN. The student can see this on their Degree Works and cannot delete it. - Most importantly, Degree Works is how students are cleared for graduation. If you see something that is not accurate, be sure to contact me. ***Otherwise, all remaining requirements listed in red are considered “still needed”.***

- **When** checking to find out when to register, the student should look at the Earned Hours (EHRS) on unofficial transcript or Degree Works in Wingspan. The number shown is the number you go by to register for the next semester.
- Registration is based on hours earned (completed), including AP, IB, CLEP, and transfer credit, and **is not affected by hours in which the student is currently registered.**
- A student may not register before his/her assigned time but may register any time after the assigned time.
- All registration is done online via [Wingspan](#).

Marge Moody, a long-standing professor in Fine Art at Winthrop University, will be presenting an exhibition celebrating her career as an artist and educator for over 30 years. Moody’s artwork emanates from her experience of different places under one large, overall theme entitled ‘Other Worlds.’ While the work differs from series to series, each is connected by common threads that reflect her experience of these particular places, or ‘worlds’, sometimes directly, often subconsciously. Line, shape, color and space are intuitively manipulated until they find their exact place in the piece as she strives to capture the essential nature of these subjects through drawing, painting and collage, and abstraction.

Jim Arendt’s exhibition is a part of the South Carolina Arts Commission’s 50th anniversary celebration that includes 15 solo and group exhibitions taking place throughout South Carolina of current and past Visual Artist Fellowship recipients. Arendt received his fellowship in 2014. His work explores the shifting paradigms of labor and place through narrative figure painting, drawing, prints, fabric and sculpture. Influenced by the radical reshaping of the rural and industrial landscapes in which he was raised, he investigates how individual lives are affected by transitions in economic structures. Arendt’s work has been exhibited internationally in numerous group and solo shows. Arendt received his B.F.A. from Kendall College of Art & Design and his M.F.A. from the University of South Carolina. He is currently an assistant professor of art and the director of the Rebecca Randall Bryan Art Gallery at Coastal Carolina University. This exhibition is supported by the South Carolina Arts Commission, South Carolina Arts Foundation and First Citizens Bank.

Whitney conducted a focus group with CVPA freshmen to evaluate their opinions on our current CVPA website. The research was mostly about their interactions with the website prior to becoming a Winthrop student, during their college search process. The results confirmed some of our suspicions about the website and its use: 1) students are mostly visiting the website on their phones; 2) prospective students are most interested in reading about current students and careers they can pursue after graduation; 3) students use of the website decreases after they become students, and they use Wingspan instead. Therefore, the website is more a recruitment tool that should be directed towards prospective students.
